



YSP Supplemental Privacy Notice - Philippines

This Privacy Notice applies to the Philippines legal entities of the Yalamanchili Group, including the Yalamanchili Solutions for Payments division ("YSP"). It serves as a supplement to the YSP Global Privacy Notice, specifically addressing key aspects of the Republic Act No. 10173 and the Data Privacy Act of 2012, and other applicable Philippine data protection laws.

In the event of any conflict between the YSP Global Privacy Notice and the YSP Supplemental Privacy Notice – Philippines, the provisions of the YSP Supplemental Privacy Notice – Philippines, along with the applicable Philippine laws and regulations governing Yalamanchili's Philippine legal entities and YSP, shall take precedence.

1. Introduction
